

COURSE DESCRIPTION

This course is intended for individuals who need to quickly become knowledgeable and proficient in basic, everyday RACF administration tasks. Unlike other administration courses, this one is specifically designed to give attendees a solid foundation in RACF without overloading them with advanced technical topics, yet it also serves as the ideal springboard for acquiring further skills and knowledge. Attendees will gain a fundamental understanding of how RACF functions along with training in creating and maintaining profiles for users, groups, datasets, and TSO resources. They will receive instructions, examples, and exercises for coding all the most commonly used RACF commands. They will also be shown how to troubleshoot typical RACF access problems. As an added benefit, attendees will examine reports from their own system to understand how their RACF is uniquely configured.
